Transfer Charge

This Carrier will assess a transfer charge of **[I]** 15.49 cents per barrel of 42 U.S. gallons each for the receipt of Crude Petroleum at Carrier's Hendrick Station, Winkler County, Texas, and delivering such Crude Petroleum to Carrier's Jal to Midland Pipeline at Hendrick Station.

Truck Unloading Charge: In addition to the transfer charge noted above, when shipments are unloaded from tank truck into the facilities of Carrier at Hendrick, Winkler County, Texas, a charge of **[I]** 18.88 cents per barrel will be made in addition to the transportation rate named herein.

Truck Loading Charge: When Crude Petroleum is loaded onto tank truck at Carrier's Hendrick Station, Winkler County, Texas, a charge of **[I]** 48.52 cents per barrel will be made.

Exceptions to the Rules and Regulations Tariff:

Rules 25(c) and 25(d) - In lieu of the nomination due date contained in Rules 25(c) and 25(d) of Rules and Regulations Tariff, the following will apply: nominations to the Carrier shall be made before 12:00 noon Central Standard Time/Central Daylight Saving Time, whichever is applicable, on the fifteenth (15th) of the month preceding the movement, as adjusted for weekends and Carrier Holidays pursuant to Rules 25(c) and 25(d).

Rule 80 - In lieu of the 0.2% loss allowance deduction stated in Rule 80 of the Rules and Regulations Tariff, the following loss allowance deduction will apply: no loss allowance.
