[W] (5) (4) The Contract Rate is available to any Shipper who executes an agreement with the Carrier with an acreage dedication for a minimum term of ten years and to any designated shipper of the contract shipper. The contract shipper must notify the Carrier in writing of any designated shipper that will be shipping on the contract shipper's behalf.

Truck Unloading Charge: Crude Petroleum unloaded from tank trucks into Carrier's facilities will be subject to a **[U]** 3.18 cent per barrel unloading charge.

Pumpover Receipt Charge: For Crude Petroleum received at Carpe Diem, Casselman Area, Midland County, Texas, an additional charge of **[U]** 18.47 cents per barrel will apply.

Pumpover Delivery Charge: Where pumping service is performed by Carrier, an additional charge of **[U]** 16.01 cents per barrel will be made on all Crude Petroleum pumped to Phillips 66 Odessa Station in the Goldsmith area.

Exceptions to the Rules and Regulations Tariff:

Rules 25(c) and 25(d) - In lieu of the nomination due date contained in Rules 25(c) and 25(d) of the Rules and Regulations Tariff, the following will apply: nominations to the Carrier shall be made before 12:00 noon Central Standard Time/Central Daylight Saving Time, whichever is applicable, on the fifteenth (15th) of the month preceding the movement, as adjusted for weekends and Carrier Holidays pursuant to Rules 25(c) and 25(d).

Rule 80 – For Crude Petroleum received at Casselman Area, Midland County and Oryx Midland Oil Gathering LLC's Ratliff Connection, Ector County, in lieu of the 0.2% loss allowance deduction stated in Rule 80 of the Rules and Regulations Tariff, the following loss allowance deduction will apply: no loss allowance.
