No. 3 supplements thereto and successive issues thereof, and are subject to change, without notice, except as otherwise provided by law.

[C] HANDLING CHARGES

When operating conditions permit, Phillips Texas Pipeline Company, Ltd. will handle through its Stations and Facilities located in following counties: Ector, Andrews, Gaines, Yoakum, Cochran, Hookley and Midland, Crude Petroleum from a connected pipeline of another carrier, or Crude Petroleum transported by truck into said facility, at the rate of [C]11.56 cents per barrel. When operating conditions permit, Phillips Texas Pipeline Company, Ltd. will accept Crude Petroleum transported by truck into the Weems truck station at the rate of 25.98 cents per barrel. When operating conditions permit, Phillips Texas Pipeline Company, Ltd. will accept Crude Petroleum out of Phillips 66 PL LLC's gathering system at University Station, Andrews County, Texas and deliver these tenders into connecting carrier systems at a rate of [C]19.08 cents per barrel. This charge will be in addition to the transportation rate named herein. When operating conditions allow, Phillips Texas Pipeline Company, Ltd. will deliver into Holly Energy Partners at Buckeye or Gaines, Crude Petroleum gathered in the Gaines area. In addition to the applicable gathering fee, a handling fee of [C]19.08 cents per barrel will be charged. When operating conditions permit, Phillips Texas Pipeline Company, Ltd. will accept Crude Petroleum out of Centurion Pipeline system at Slaughter Station, Cochran County, Texas. In addition to the applicable tariff above, a handling fee of [C]25.41 cents per barrel will be charged. When operating conditions permit, Phillips Texas Pipeline Company, Ltd. will transfer Crude Petroleum out of Centurion Pipeline system at Ector Station, Ector County, Texas to Odessa Station, Ector County, TX for a fee of [C]6.05 cents per barrel.

LINE REVERSAL

The pre-dominant direction of the pipeline is from south to north. However, at the sole discretion of PTPL when operating conditions permit, PTPL will move Crude Petroleum from origin stations located between Odessa Station and Phillips, Texas to Odessa Station at a charge of [C]75.32 cents per barrel.

GATHERING CHARGES

When gathering service is performed at point of origin, a charge will be made as provided under "GATHERING CHARGES" in the rate table above, and shall be in addition to the charges for transportation.

Exception to Rule 9 of Amended Rule 71(A), State of Texas

GAUGING, TESTING AND DEDUCTIONS: A deduction of two tenths of [C] one percent (0.2%) will be made to cover evaporation and other normal losses during transportation.

Exception to Rule 5

STORAGE: All Shippers must provide storage at origin and destination.
