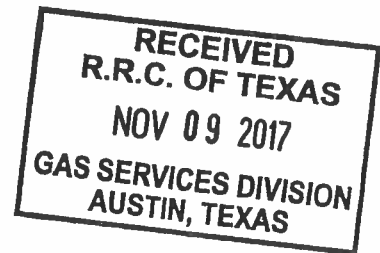

Additional Fees:

Lost and Unaccounted For Allowance: Shipper shall bear its allocated share of actual losses through normal operations in the movement of Shipper's Condensate from the Receipt Points to the Delivery Point(s).

Pumping Charge: Where pumping service is performed by Transporter, an additional charge of \$.50 per Barrel will be made on all condensate pumped directly into another carrier's system. The Pumping Charge for Firm Service Shippers is included in the Fixed Rate set forth above.

Hand Run Gauging Fee: There will be an additional charge of \$1.00 per Barrel on gathered condensate which is hand run gauged. The Hand Run Gauging Fee for Firm Service Shippers is included in the Fixed Rate set forth above.
