## Rates in Dollars per Barrel

### BASE RATE FOR VOLUMES SHIPPED

Shippers shall pay a rate (as escalated per the methodology below) for each barrel shipped (based on average daily volume for the month).

FROM:	TO:	BASE RATE:
Gridiron North Tank Battery	Centurion Curtis Ranch Interconnect	\$1.25/Bbl *

**\* Note: discounts may be given for a shipper that enters into a Gathering Agreement, with a term not less than five (5) years, and commit minimum volume amounts or make acreage or production dedications.**

### QUALITY BANK FEES

Shippers shall pay rates as stated below for any month in which the Carrier has instituted a Quality Bank, subject to the conditions and limitations in the Rules and Regulations tariff.

FEE:	RATE:
Administrative Fee	\$0.005 per barrel shipped
Quality Adjustment Fee	\$0.03 per 0.10° API differential

### ESCALATION METHODOLOGY

The Base Rate shown above shall escalate each year, commencing on September 1, 2016 (and continuing annually on September 1 of each year thereafter until this Tariff is amended). The Gathering Fee in effect on the day immediately preceding the fee escalation date shall be multiplied by a fraction, the numerator of which is the Consumer Price Index, All Urban Consumers, U. S. City Average, All Items, as published by the U. S. Department of Labor, Bureau of Labor Statistics (CPI-U), or its most comparable successor, for the month of August of the then-current year, and the denominator of which is the CPI-U for the month of August of the year immediately preceding the fee escalation date. Notwithstanding the foregoing, the fee(s) shall never decrease, as a result of the foregoing adjustments, below the amounts set forth above. Interest will be due on payments not made when due, as provided in Special Rule 17 of the Rules and Regulations Tariff.
