LINE REVERSAL

The pre-dominate direction of the pipeline is from south to north. However, at the sole discretion of P66 Carrier, when operating conditions permit, P66 Carrier will move Crude Petroleum from origin stations located between Odessa Station and Phillips, Texas to Odessa Station at a charge of [1] 78.80 cents per barrel.

GATHERING CHARGES

When gathering service is performed at point of origin, a charge will be made as provided under "GATHERING CHARGES" in the rate table above, and shall be in addition to the charges for transportation.
