No. [W] 49.10.0 49-8-0, supplements thereto and reissues thereof, with respect to that portion of the transportation services provided by Magellan Pipeline Company, L.P., (respectively, the "Phillips 66 Rules" and the "Magellan Rules"). Any conflicts between the terms of the Magellan Rules and the Phillips 66 Rules with respect to the entirety of the joint pipeline transportation governed by this Tariff shall be resolved in favor of the governed by the applicable provision of the Magellan Rules.
