INCREMENTAL POWER FEE (for all movements to Midway [W] Station Junction only):

In any given month, for each barrel delivered over a daily average rate of 62,500 barrels per day but less than the daily average rate of 72,000 barrels per day, there shall be an incremental power fee of **[II]** forty-six and ninety-eight hundredths cents (\$0.4698) per barrel in addition to the transportation rates named herein.

In any given month, for each barrel delivered over a daily average rate of 72,000 barrels per day, there shall be an incremental power fee of **[II]** fifty-two and two tenths cents (\$0.5220) per barrel in addition to the transportation rates name herein.
