Any Shipper desiring to avail itself of the Monthly Tiered Volume Incentive Rates to the Galveston Bay, TX – Marathon Refinery (Galveston County), Texas City, TX- Marathon Refinery (Galveston County) and/or [N] Texas City, TX – MPLX Marathon Terminal ("Incentive Destination") must satisfy the following tiered volume provisions:

- An individual Shipper must ship and deliver Crude in its own name in the amount of the Tier 1 Minimum Monthly Volume Threshold of 100,000 barrels per day ("bpd") per month to the Incentive Destination.
- In addition to satisfying the Tier 1 Minimum Monthly Volume Threshold, the Tier 2 Minimum Monthly Volume Thresholds of 125,000 bpd, 150,000 bpd or 175,000 bpd must be satisfied by the accumulation of the total volume shipped and delivered by all Shippers within the month to the Incentive Destination to satisfy the respective Incentive rates.
- Volume shipped and delivered from the origination points of OTI Jct, Pasadena, TX; Genoa Jct., TX , Magellan East Houston Terminal, TX and Galena Park MTH, TX can be used to satisfy the Tier 1 and Tier 2 Minimum Monthly Volume Thresholds to the Incentive Destination.
- If any participating Shipper is unable to satisfy the requirements of Tier 1 and/or Tier 2 Minimum Monthly Volume Thresholds due to the Incentive Destination experiencing a planned refinery turnaround (a "Planned Turnaround"), and provided that Carrier has received sixty (60) days advance written notice of such Planned Turnaround, then during the month(s) that such Planned Turnaround occurs, Carrier shall charge participating Shippers that met the Tier 1 and Tier 2 Minimum Monthly Volume Thresholds during each of the prior three months (disregarding any month of a Planned Turnaround) the average tariff paid by such Shippers for transportation of Crude to the Incentive Destination during such prior three months.

The Volume Incentive Rates set forth in this Item will apply only to the deliveries of Crude to the Incentive Destination from the Incentive Origin Points defined as Genoa Jct., TX and OTI Jct., Pasadena, TX.

For any Shipper who meets the above listed tiered volume provisions in any calendar month, Carrier will invoice the Shipper at the applicable Volume Incentive Rates set out in this Item. If a Shipper does not meet the above listed tiered volume provisions in any calendar month, Carrier will invoice the Shipper at the applicable current- base rates set out in Items 100 or 300 of this tariff.
