Governed, except as otherwise provided herein, by Rules and Regulations published in Plains Oryx Permian Basin Pipeline LLC's TX No. 29.0.0 or reissues thereof ("Rules and Regulations Tariff").

[N] The rates for Crude Petroleum movements to Joe Mabee Station, Martin, County, Texas are hereby cancelled in their entirety. No further rates or routing will be provided.

Effective November 1, 2022, certain of the assets of Plains Oryx Permian Basin Pipeline LLC are now owned by Oryx Midland Oil Gathering LLC. For the cancelled rates set forth herein with the Midland, Midland County destination point, refer to Oryx Midland Oil Gathering LLC's TX No. 3.0.0 for further rates and routing.

~~[C] INJECTION FEE: For Crude Petroleum injected into Carrier's pipeline at Comanche Station, Martin County, Texas, an injection fee of [U] 12.10 cents per barrel will be charged for delivery into Carrier's pipeline.~~

~~UNLOADING CHARGE: Shipments unloaded from tank truck facilities into Carrier gathering facilities will be subject to the Gathering Charge. There will be no charge for crude oil unloaded from tank truck facilities at Mabee South Station. All other shipments unloaded from tank truck facilities into the mainline facilities of the Carrier will be subject to a charge of [U] 11.21 cents per barrel.~~

~~PUMPING CHARGE: Where pumping service is performed by Carrier from its facilities at Midland to (i) Plains Pipeline, L.P. or Enterprise Pipeline's Basin Pipeline; or, (ii) Carrier's Spraberry Pipeline, a charge of [U] 11.21 cents per barrel of 42 U.S. gallons will be made on all Crude Petroleum pumped into the other system, except that there will be no pumpover charge for Crude Petroleum received at Mungerville Field—University 7-14 Gathering, Scharbauer Mabee Station or Mabee South Station.~~

Exceptions to the Rules and Regulations Tariff:

~~[C] Rule 7: The pipeline loss allowance of two-tenths of one percent specified in the rules and regulations will not apply to University Comanche Gathering, Martin County or movements from Curtis Station, Martin County to Midland Station, Midland County.~~

~~For Crude Petroleum received at Lowe Area Mabee Wolfberry Gathering, Andrews and Martin Counties, the deduction for incremental evaporation and shrinkage shall be determined in accordance with the following table:~~

API Gravity, Degrees	Deduction for Incremental Evaporation & Shrinkage
Less than 60.0	-0.0%
60.0 through 74.9	-5.0%
75.0 and above	10.0%

Rule 11 - In lieu of the nomination due date contained in Rule 11 of the Rules and Regulations Tariff, the following will apply: nominations to the Carrier shall be made before 12:00 noon Central Standard Time/Central Daylight Saving Time, whichever is applicable, on the fifteenth (15th) of the month preceding the movement, as adjusted for weekends and Carrier Holidays pursuant to Rule 11.
