This letter of credit may be terminated during its term only if we are provided with a letter from you stating that each of the above-referenced Produced Water Recycling Pit(s) has been closed in a manner that meets your requirements or on such date as you authorize the release of this Letter of Credit.

The document specified below must be presented at sight on or before the expiry date in accordance with the terms and conditions of this Irrevocable Standby Letter of Credit:

- A. This Irrevocable Standby Letter of Credit or a copy thereof; and
- B. An affidavit from the Railroad Commission of Texas or its authorized representative, stating that Produced Water Recycling Pit(s) subject to this Letter of Credit has not provided a substitute letter of credit that has been accepted by the Railroad Commission of Texas or its authorized representative or has defaulted on its obligation under state law, Railroad Commission rules, or is likely to pollute or polluting any ground or surface water, or is not being maintained in compliance with state law and the Railroad Commission rules relating to the prevention or control of pollution.

We engage with you that drafts drawn under and in conformity with the terms and conditions stated above will be duly honored on presentation if presented to us at our office at the address shown above or any of our bank branches on or before the expiry date.

The credit is subject to the Uniform Customs and Practice for Documentary Credits (revision in force as of July 1, 2007), International Chamber of Commerce –Publication 600.
