AMENDMENT NO. 1 CONTRACT NO. 455-20-1001A between RAILROAD COMMISSION OF TEXAS and CGI TECHNOLOGIES AND SOLUTIONS INC.

THIS AMENDMENT NO. 1 to Contract No. 455-20-1001 now referred to as Contract No. 455-20-1001A ("Contract") is entered into by and between the State of Texas, acting through the Railroad Commission of Texas ("RRC"), located at 1701 N. Congress Ave., Austin, Texas and CGI Technologies and Solutions Inc. ("Contractor"), located at 111 Congress Ave. Ste. 400, Austin, TX 78701 (individually, "Party"; collectively, "Parties").

WHEREAS, SECTION 8.8. of the Contract provides the Parties may amend the Contract through written agreement; and

NOW, THEREFORE, the Parties agree to amend the Contract as follows:

I. **SECTION 2.1. CONTRACT AWARD.**, subparagraph (a.) is deleted in its entirety and replaced with the following:

"This Contract shall be effective as of the date of the last Party's signature to the original Contract and shall continue through August 31, 2023 (the initial term of the Contract plus the exercised optional renewal term one of three; collectively, "Contract Term") unless terminated earlier as provided in RFO No. 455-20-1001 Part IV and/or section **2.2 TERMINATION.**, set forth below.

This Contract may be extended only through written amendment to the Contract, fully executed prior to the expiration of the Contract Term in effect prior to execution of the applicable Amendment to the Contract.

RRC reserves the right to renew the Contract for two (2) additional, one-year renewal terms remaining of the original three (3) one-year renewal terms."

Except as expressly amended above, all provisions of the Contract as amended through Amendment No. 1, remain in full force and effect. In the event of a conflict among provisions of the Contract, the order of precedence shall be: this Amendment No. 1; and then the original Contract in accordance with section **1.3. ORDER OF PRECEDENCE.**, therein.
