#### **Exception to Sunrise Pipeline LLC's Rules and Regulations Tariff:**

### Section 2-Explanation of Terms and Abbreviations will be supplemented and amended as follows:

"Nomination Date" means the fifteenth (15th) of the month preceding the movement, as adjusted for weekends and Carrier Holidays pursuant to Rule 30(c).

Rule 26 – Unloading Charge: When shipments are unloaded from tank truck into the facilities of Sunrise Pipeline LLC, a charge of [U] 11.88 cents per barrel will be made in addition to the transportation rate named herein.

Rules 30(c) and 30(d)- In lieu of the nomination due date contained in Rules 30(c) and 30(d) of the Rules and Regulations Tariff, the following will apply: nominations to the Carrier shall be made before 12:00 noon Central Standard Time/Central Daylight Saving Time, whichever is applicable, on the fifteenth (15<sup>th</sup>) of the month preceding the movement, as adjusted for weekends and Carrier Holidays pursuant to Rules 30(c) and 30(d).

#### Rule 31E - Incremental Evaporation and Shrinkage

a) For Crude Petroleum gathered into or received at the Origin Points contained herein, the deduction for incremental evaporation and shrinkage shall be determined in accordance with the following table:

API Gravity, Degrees	Deduction for Incremental Evaporation & Shrinkage
Less than 60.0	0.0%
60.0 through 74.9	5.0%
75.0 and above	10.0%
