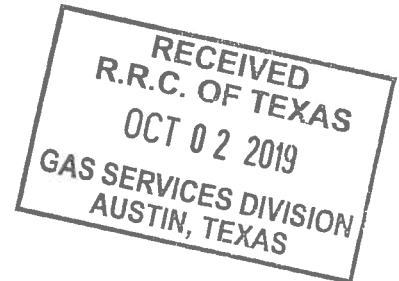

Except as otherwise expressly provided herein, the rates published in this tariff and the services hereunder are governed by the Rules and Regulations published in ExxonMobil Pipeline Company's Texas Intrastate No. 208.4.0, supplements thereto and reissues thereof with respect to that portion of the transportation services provided by ExxonMobil Pipeline Company and Magellan Pipeline Company, L.P.'s Texas R.C.T. No. 49.11.0, supplements thereto and reissues thereof, with respect to that portion of the transportation services provided by Magellan Pipeline Company, L.P. (respectively, the "ExxonMobil Rules" and the "Magellan Rules"). Any conflicts between the terms of the Magellan Rules and the ExxonMobil Rules with respect to the entirety of the joint pipeline transportation governed by this Tariff shall be resolved in favor of the governed by the applicable provision of the Magellan Rules.
