A Category D license is required if your company has one or more employees who hold a Railroad Commission LP-gas certification (e.g., service and installation), but do not hold a master or journeyman plumber's or ACR contractor's license.

\*Disclosure of applicant's Social Security number is mandatory under Section 231.302(c) of the Texas Family Code and will be used to assist in the administration of laws relating to child support and for recordkeeping by the Commission.

**CERTIFICATION:** I certify that I am a Master or Journeyman Plumber currently licensed by the Texas State Board of Plumbing Examiners, or a Class A or B Air Conditioning and Refrigeration Contractor currently licensed by the Texas Department of Licensing and Regulation. I have read the current edition of the Railroad Commission's *LP-Gas Safety Rules* and will comply with the requirements of those rules. If I lose my qualified status as a Master or Journeyman Plumber or Class A or B Air Conditioning and Refrigeration Contractor, the registration card will be returned immediately to the Commission, and I will surrender all rights and privileges of registration. I understand that the registration accrues only to me and is non-transferable.

**All LPG registrations expire at midnight on May 31 of each year.**
