General Instructions

This form must be completed to apply for initial certification or to renew an existing certification.
It is the individual's record of course attendance and/or application for examination.

Registration Information

1) Check the box or boxes that apply for your registration. For example, if the individual is registering for an initial course of instruction class with an exam then check both boxes.

2) Complete the *Course Date* and *Location*. The *Course Number* and *Title* can be found on the on-line reservation.

Applicant Information

3) Complete the student's name and address contact information. The *Social Security Number* is required.

The *RRC License Number* is required and is found on the company wall license. If the individual is not employed by a company leave the *Company Name* and *RRC Company License Number* blank.

Classes

4) Check the category of class for which the individual is registering. Note that continuing education completed before the individual's due date is free. If the continuing education is taken late, a class fee as well as the late fee is due.

Employee-Level Examinations

5) Select the employee-level or management-level examinations needed.

A-3 Bobtail Driver – Covers the activities of Bobtail Driver, Transport Driver, DOT Cylinder Filler, Motor/Mobile Fuel Filler as well as performing leak checks, pressure tests, lighting appliances and adjusting regulators.

B-3 Service and Installation Technician – Covers activities related to stationary LP-Gas systems including containers, appliances and stationary engines except for filling.

C-3 Transport Driver – Allows operation of an LP-Gas transport including loading, unloading and connection and disconnection of transfer hoses.

D3M Mobile Fuel Technician – Covers the installation of mobile fuel containers, cylinders and mobile fuel systems including replacement of container valves. It does not authorize filling.

D3N Non-Road Motor Fuel Technician – Covers the installation of motor fuel containers, cylinders and motor fuel systems including replacement of container valves on vehicles like forklifts and lawnmowers. It does not authorize filling.

D3O On-Road Motor Fuel Technician – Covers the installation of motor fuel containers, cylinders and motor fuel systems including replacement of container valves on vehicles licensed to operate on public roadways. It does not authorize filling.

E-3 DOT Cylinder Filler - Covers activities related to DOT cylinders including inspecting, requalifying, filling, connecting and disconnecting cylinders and exchanging cylinder valves.

F-3 Motor/Mobile Fuel – Covers the inspection and filling of motor or mobile fuel containers on recreational vehicles, cars, trucks and buses.

G-3 Recreational Vehicle Technician – Covers the installation of motor and mobile fuel containers including cylinders and the installation and repair of LP-Gas systems. It does not authorize filling.

I-3 Appliance Service and Installation Technician – Covers activities related to appliances including installing, repairing and converting appliances, installing and repairing connectors from the gas stop through the venting system and performing leak checks.

For a full explanation of the activities of each employee-level certification see Section 9.10 of the LP-Gas Safety Rules.

Management-Level Examinations
