TRUCK HANDLING CHARGE – An additional charge of **[U]** nine and fifty-three one-hundredths cents (9.53¢) per barrel will be charged for truck receipts made into Andrews Station, Andrews County, Texas; Mallet Station, Hockley County, Texas; Seminole Station, Gaines County, Texas; and Fullerton Station, Andrews County, Texas. Truck receipts at these locations will be subject to the TRUCK HANDLING CHARGE in addition to the trunk line rates from the origins defined above in the brackets.
