### **EXCEPTION TO TEXAS Intrastate No. 1.2.0, RULE 16 - OFFER IN EXCESS OF FACILITIES:**

Volumes nominated on this tariff with the destination of ExxonMobil Pipeline, Channelview Junction, Harris County, Texas ("Short Haul" volumes) are transported concurrent with volumes originating at Houston delivering downstream [including, but not limited to: (Zydeco Pipeline Company LLC's F.E.R.C. No. ~~[W] 6.25.0 6.27.0~~) to Houma, Louisiana and Clovelly, Louisiana and St. James, Louisiana and (Zydeco Pipeline Company LLC's F.E.R.C. No. ~~[W] 7.16.0 7.17.0~~) to Nederland, Texas and Port Neches, Texas and Lake Charles, Louisiana ("Long Haul" volumes)]. In the event total Short Haul and Long Haul volumes nominated to ExxonMobil Pipeline, Channelview Junction, or any points downstream of Channelview Junction, exceed the capacity of the line segment, Carrier shall first allocate capacity to the Long Haul volumes nominated. Remaining capacity will then be allocated among Short Haul shippers in proportion to the Short Haul volumes nominated.
