## **October is Energy Awareness Month**

For over thirty years, October has been National Energy Awareness Month, highlighting the importance of the nation's energy resources and the need for sustainable management.

Since the Industrial Revolution, fossil fuels have made our modern world possible by producing nearly 80 percent of global energy. Produced hydrocarbons play a crucial role in our lives, from providing fuels for transportation, electricity, and heating to manufacturing everyday consumer materials like plastics, medicine, medical devices, fabrics, fertilizers, and other byproducts of oil refining, such as asphalt for roads.

As the regulator of the largest oil and gas-producing state in the nation, the Railroad Commission plays a vital role in the stewardship of natural resources, ensuring public safety, and supporting the state's long-term economic vitality in the energy landscape.

"Texas is the national leader in energy production," said Chairman Christi Craddick. "Energy Awareness Month is a great opportunity to highlight this industry's positive impact on Texas, the U.S., and the world."

## **SB 1186 (88R) Proposed New Rule**

During the October 15th RRC Open Meeting the Commissioners approved new Rule §3.82, Brine Production Projects and Associated Brine Production Wells and Class V Spent Brine Return Injection Wells, and amendments to other rules in RRC Oil & Gas Division Rules, Chapter 3.

New Rule §3.82 will implement the requirements of SB 1186 (88R), which amended Texas Water Code §27.036 to clarify the Commission's jurisdiction over brine mining under state law-the proposed rules to be posted in the November 1st Texas Register and comment period ending December 2nd.
