Where gathering service is performed by Carrier, the gathering charge will be made in addition to all other transportation charges. For trunk line service see: Carrier’s TX No. 52.0.0, supplements thereto and reissues thereof.

<sup>1</sup>With respect to movements from Collie Field GS to Plains PL Barstow Station in this tariff and any supplements thereto, the following language shall replace Rule 20 of Carrier’s TX No. 50.0.0, and any supplements thereto.

20. Gauging, Testing, and Deductions

- A. All shipments nominated to Carrier for transportation shall be tested, gauged or metered by a representative of Carrier prior to or at the time of its receipt from the Shipper of its delivery to Consignee. Shipper or Consignee shall at all times have the privilege of being present or represented during the testing, gauging or metering. Carrier shall correct all quantities as to temperature from observed temperature to 60 degrees Fahrenheit by use of applicable API-ASTM-IP correction tables. Carrier will make a full deduction for all water and other impurities.
- B. Carrier shall account to each Shipper for all Crude Petroleum received. Any overage or shortage not due to the negligence of Carrier, including losses or gains resulting from shrinkage, evaporation, expansion or other Crude Petroleum losses or gains inherent in the operation of a pipeline system, will be allocated on a monthly accrual basis among the Shippers in the proportion that the total number of Barrels delivered from the pipeline system for each Shipper bears to the total number of Barrels delivered from the pipeline system for all Shippers.
- C. The net balance, after applicable deductions defined above, and any loss as provided for in Paragraph 24 (Liability of Carrier), will be the quantity deliverable by Carrier and upon which transportation charges will be assessed.

Means GS	Kinder Morgan Pipeline, L.P.’s Wink Station, Winkler County, Texas	[I] 112.79	Incentive rate will apply to any Shipper that has entered into and has an effective throughput and deficiency agreement with Carrier or any Shipper shipping on behalf of a producer that has entered into and has an effective throughput and deficiency with Carrier, pursuant to which the Shipper or producer, as applicable, has agreed to ship or have shipped on its behalf, or otherwise pay for not shipping, a minimum volume amount from Means GS through to Kinder Morgan Pipeline, L.P.’s Wink Station (“KM Wink Station”). For clarity, the movement to which the incentive rate applies comprises (i) gathering service from Means GS to Ector Station under this tariff, and (ii) trunk line service from Ector Station to KM Wink Station under Carrier’s TX No. 54.
West Means GS	Midland Tank Farm	[I] 73.62	The all-inclusive incentive rate shall apply to any Shipper that has entered into and has an effective dedication agreement with Carrier or any Shipper shipping on behalf of a producer that has entered into and has an effective dedication agreement with Carrier with respect to gathering and transportation service from West Means Unit to Midland Tank Farm (West Means Dedicated Shippers”). For clarity, the movement comprises (i) gathering service and (ii) trunk line service from West Means Unit to Midland Tank Farm. Rates are applicable for a dedicated Shipper that tenders the stated barrels per day, on average, during a month for the noted service.
