1.4. Short Term Contractual Shipper Rates

Each Short Term Contractual Shipper will pay Carrier the applicable rates below as applied to its Short Term Contractual Shipper Crude Oil:

- *Annual Adjustment: The gathering fee will be adjusted each July 1 beginning July 1, 2017 in accordance with the FERC indexing methodology as described in 18 C.F.R. § 342.3, except that the gathering fee for any Short Term Contractual Shipper will never be lower than the than \$0.90 per Barrel under this adjustment. The only circumstance in which the gathering fee will be lower than \$0.90 per Barrel is set forth as Note 1 below.
- **Short Term Contractual Shipper Election to Not Deliver: If Short Term Contractual Shipper elects to not deliver part or all of the Short Term Contractual Shipper Crude Oil that is deliverable to a Short Term Contractual Shipper Receipt Point, Short Term Contractual Shipper is still obligated to pay Carrier the Short Term Contractual Shipper Gathering Fee for all Barrels of Short Term Contractual Shipper Crude Oil sold by Short Term Contractual Shipper that otherwise could have been delivered to a Short Term Contractual Shipper Receipt Point and received by Carrier.
- ***Short Term Contractual Shipper Downstream Transportation and Sale: Short Term Contractual Shipper is also responsible for arranging (i) all transportation downstream of the Short Term Contractual Shipper Delivery Point and (ii) the disposition and sale of the Short Term Contractual Shipper Crude Oil. If Short Term Contractual Shipper fails to do so, Carrier or its Affiliates may arrange for the disposition and sale of the applicable Short Term Contractual Shipper Crude Oil and remit the net proceeds to Short Term Contractual Shipper (after deducting a fee of \$0.15 per Barrel).
- Note 1: Gathering Fee Adjustment After Recovery of Applicable Construction and Installation Costs: After the total Short Term Contractual Shipper Gathering Fees paid by a Short Term Contractual Shipper equals the total costs incurred by Carrier to construct and install all applicable additional facilities and connections to serve the Short Term Contractual Shipper, then the Short Term Contractual Shipper Gathering Fee will be credited or reduced by \$0.15 for that Short Term Contractual Shipper.
