**Truck Unloading Charges:** Crude Petroleum unloaded from tank trucks into Carrier's facilities will be subject to the following unloading charges.

**Truck Loading Charge:** When Crude Petroleum is loaded onto tank truck at Carrier's Crane East or Crane West Stations, Crane County, Texas, a charge of [I] 48.52 cents per barrel will be made.

**Pumpover Charges:** Where pumping service is performed by Carrier, an additional charge will be made on all Crude Petroleum pumped into connecting carrier.

**Exceptions to the Rules and Regulations Tariff:**

**Rules 25C and 25D-** In lieu of the nomination due date set forth in Rules 25C and 25D of the Rules and Regulations Tariff, the following will apply: nominations to the Carrier shall be made before 12:00 noon Central Standard Time/Central Daylight Saving Time, whichever is applicable, on the fifteenth (15<sup>th</sup>) of the month preceding the movement, as adjusted for weekends and Carrier Holidays pursuant to Rules 25C and 25D.

**Rule 80E:** In lieu of the gravity table set forth in Rule 80E of the Rules and Regulations Tariff, the deduction for incremental evaporation and shrinkage shall be determined in accordance with the following table:

<u>API Gravity, Degrees</u>	<u>Deduction for Incremental Evaporation &amp; Shrinkage</u>
Less than 60.0	0.0%
60.0 through 74.9	5.0%
75.0 and above	10.0%
