NOTES

1. The Karnes City Truck Unloading Facility is not part of the Pipeline Operator's System. Therefore, in order to use the Karnes City Truck Facility to access Pipeline Operator's System, a shipper must make arrangements with the third-party licensor of this facility.
2. The Committed Rates are available to any shipper that signed a TSA with Pipeline Operator for a ten year initial term and dedicated therein at least 95,000 acres.
3. The Uncommitted Rates are applicable to all shippers who do not qualify as a Committed Shipper.
4. In the event that a Committed Shipper nominates and delivers in excess of 60,000 barrels per day (on an average daily basis) from any origin point to any destination point listed herein during a month, the delivered volumes of that Committed Shipper that exceed 60,000 barrels per day (on an average daily basis) will be charged a rate of [I] \$0.81.39 per barrel.
5. If a Committed Shipper makes a Nomination to this Destination, the portion of that Nomination that will be treated as part of the Committed Shipper's Committed Volume for the month under Item No. 34.C of Carrier's TRRC Tariff No. 1.0, supplements thereto and reissues thereof, will be subject to any applicable limitations in the Committed Shipper's TSA. Any portion of the Committed Shipper's Nomination that is not considered part of its Committed Volume will be subject to allocation under Item Nos. 34.D-F of Carrier's TRRC Tariff No. 1, supplements thereto and reissues thereof.
6. **PUMPOVER CHARGE:** All shipments that are delivered into Sunoco/NuStar's South Texas System and are subject to the Uncommitted Rate for service listed herein will be subject to a pump-over charge of [I] ten and twenty hundredths cents (\$0.1020) per barrel in addition to the Uncommitted Rate listed herein.
7. [N] Any shipper that enters into a Transportation Services Agreement with Carrier and agrees therein either to (i) ship or otherwise pay Carrier for failing to ship a specified volume of crude oil or (ii) dedicates certain production for delivery to Carrier's system, in each case, for a period of at least one year, may qualify for a Committed Shipper Rate for the movement. Interested shippers should contact Carrier for more information.
