Notice of Temporary Embargo

Effective February 3, 2020, transportation service from Parks GS in Midland County, Texas to the Midland Tank Farm in Midland County, Texas is under a temporary embargo ("Embargoed Service"). Carrier is implementing the temporary embargo so that it can address certain integrity-related issues associated with the facilities used to provide the Embargoed Service. This temporary embargo will remain in place until a tariff is filed to reinstate the Embargoed Service. The Embargoed Service is denoted by the symbol "[E]". All other transportation services under this tariff are unaffected by this embargo.

The provisions published herein will, if effective, not result in an effect on the quality of the human environment.
