## Routing for Joint Rates in Table Above:

Anchor Crude's pipeline system from Founders Central Eidson Battery, Ector County, Texas to ET-S Permian's Judkins Station in Ector County, Texas; then ET-S Permian's pipeline system from Judkins Station in Ector County, Texas to Magellan Crane Terminal, Crane County, Texas.

## Notes Applicable to Table of Joint Rates

Note 1: The applicable rate will be applied to those barrels that fall within each specific Volume Tranche based on average daily barrels shipped by Shipper during a month. Specifically, the Base Rate Volume Tranche would apply for the first 1,500 bpd shipped by a Shipper, the Tier 1 Rate Volume Tranche would apply for the barrels 1,501 to 3,000 bpd shipped by a Shipper, and the Tier 2 Rate Volume Tranche would apply to any barrels in excess of 3,000 bpd shipped by a Shipper. An example illustrating the application of rates under this tariff is shown below:

Example: Average Daily Barrels Shipped in Month X: 3,800; Month X: 31 days

Barrels	Transportation Rate (\$/Barrels)	Daily Rate	Monthly Rate
First 1,500 BPD	\$2.0541	\$3,081.15 ( $\$2.0541 \times 1,500$ )	\$95,515.65 ( $\$3,081.15 \times 31$ )
Next 1,499 BPD	\$1.7443	\$2,614.71 ( $\$1.7443 \times 1,499$ )	\$81,056.01 ( $\$2,614.71 \times 31$ )
Last 801 BPD	\$1.4344	\$1,148.95 ( $\$1.4344 \times 801$ )	\$35,617.45 ( $\$1,148.95 \times 31$ )
