Texas No. **[W]** ~~49.23.0~~ ~~49.22.0~~, supplements thereto or successive issues thereof with respect to that portion of the transportation services provided by Magellan Pipeline Company, L.P. and KPL South Texas, LLC's Texas No. **[W]** ~~62.4.0~~ ~~62.4.0~~, supplements thereto and reissues thereof, with respect that portion of the transportation services provided by KPL South Texas, LLC, (respectively, the "Magellan Rules" and the "KPL Rules"). Any conflicts between the terms of the Magellan Rules and the KPL Rules with respect to the entirety of the joint pipeline transportation governed by the Tariff shall be resolved in favor of the governed by the applicable provision of the Magellan Rules.
