**Rule 80D** – In lieu of the specifications stated in Rule 80D of the Rules and Regulations Tariff the following loss allowance will apply: no loss allowance.

**Rule 110A** – In addition to the provisions set forth in Rule 110A, when shipments are unloaded from tank truck into the facilities of Carrier, a charge of [I] 13.75 cents per barrel will be made in addition to the transportation rates contained herein.
