1. [W] Enterprise Interstate Crude Pipeline LLC ~~Ironwood Midstream Energy Partners, LLC~~ – From the Mockingbird Battery located in Midland County, Texas to the ET-S Permian Pipeline Company LLC interconnect in Midland County, Texas.
2. ET-S Permian Pipeline Company LLC – From the [W] Enterprise Interstate Crude Pipeline LLC ~~Ironwood Midstream Energy Partners, LLC~~ interconnect in Midland County, Texas to the Midland Tank Farm in Midland County, Texas.

Exceptions to the ET-S Permian Pipeline Company LLC’s Rules and Regulations, TX No. 50.0.0 or subsequent reissues thereof:

For movements under this joint tariff, transportation charges will be assessed on the net volumes received before any adjustment for losses. A pipeline loss allowance of one tenth of one percent (0.1%) will be deducted from the quantity of Crude Petroleum received into ET-S Permian Pipeline Company LLC’s system to cover shrinkage, evaporation, and other normal losses that occur during the transportation of Crude Petroleum on ET-S Permian Pipeline Company LLC’s system under this joint tariff. Additionally, a shipper shall be responsible for its pro-rata share of actual gains and losses of Crude Petroleum that occur during transportation on Crude Petroleum on [W] Enterprise Interstate Crude Pipeline LLC ~~IMEP’s~~ system under this joint tariff.
