Exception to Rule 45 e in the Rules and Regulations:

[W] Net of Carrier's adjustment for basic sediment, water, and other impurities, all Tenders of Crude Petroleum shall also be subject to an adjustment (positive or negative) to account for inherent gains or losses, including but not limited to shrinkage, evaporation, interface gains or losses and normal "over and short" gains or losses, with such adjustment determined by Carrier on the basis of total quantities transported for the applicable crude movement(s), based on actual historical experience. Carrier may take a volumetric deduction of up to 0.20% of the quantity of Crude accepted for receipt at Pipelines Origin to account for actual losses incurred during handling of Crude. Losses exceeding this ceiling will be financially settled with shipper by taking the average midpoint values of Light Louisiana Sweet crude oil as published by Argus Americas Crude for calendar month in which losses took place.

Exception to Rule 95 in the Rules and Regulations

Carrier provides no facilities for storage and will provide only minimal working tankage for storage that is incidental and necessary to the transportation of Crude Petroleum. Non-incident storage at the Origin and Destination Point is a separate service which Shipper must negotiate and obtain from Carrier or another party.
