### Section 2-Explanation of Terms and Abbreviations will be supplemented and amended as follows:

"Nomination Date" means the fifteenth (15<sup>th</sup>) of the month preceding the movement, as adjusted for weekends and Carrier Holidays pursuant to Rule 30(c).

**Rule 26 – Unloading Charge**: When shipments are unloaded from tank truck into the facilities of Sunrise Pipeline LLC, a charge of **[I]** 15.13 cents per barrel will be made in addition to the transportation rate named herein.

**Rules 30(c) and 30(d)**- In lieu of the nomination due date contained in Rules 30(c) and 30(d) of the Rules and Regulations Tariff, the following will apply: nominations to the Carrier shall be made before 12:00 noon Central Standard Time/Central Daylight Saving Time, whichever is applicable, on the fifteenth (15<sup>th</sup>) of the month preceding the movement, as adjusted for weekends and Carrier Holidays pursuant to Rules 30(c) and 30(d).

#### Rule 31E – Incremental Evaporation and Shrinkage
