Contract Rates are available to all Shippers, or their designated shipper, that have signed a dedication agreement or a throughput and deficiency agreement with Advantage Pipeline LLC after January 1, 2017.

Contract Incentive Rates shall apply on a calendar month basis to all shipments of Committed Shippers in excess of their contractual obligations for such calendar month.

Annual Adjustments: Unless otherwise specified in the applicable shipper agreement, fees may be adjusted each July 1 in accordance with the indexing methodology of the Federal Energy Regulatory Commission ("FERC") as described in 18 CFR 342.3, subject to the following qualifications:

- (i) In a given year (July 1 through June 30), Advantage Pipeline LLC's maximum annual adjustment will be the lesser of (a) the generally applicable index adjustment as published by FERC for that given index year, or (b) a rate established by carrier.
- (ii) In the event application of the index adjustment as published by FERC for a given index year would result in a rate decrease, no index adjustment will be made.

TRUCK UNLOADING CHARGES: In addition to the charges contained in paragraph 40, Section II of Texas 1, supplement 1, any crude petroleum unloaded from tank trucks into Carrier's facilities at Hwy 285 South Station or Hwy 18 Station facilities will be subject to an additional **[U]** 8.15 cents per barrel.
