~~INJECTION FEE: For Crude Petroleum injected into Plains Pipeline, L.P.'s pipeline at Comanche Station, Martin County, Texas, an injection fee of [C] 11.13 cents per barrel will be charged for delivery into Carrier's pipeline.~~

~~UNLOADING CHARGE: Shipments unloaded from tank truck facilities into Carrier gathering facilities will be subject to the Gathering Charge. There will be no charge for crude oil unloaded from tank truck facilities at Mabee South Station. All other shipments unloaded from tank truck facilities into the mainline facilities of the Company will be subject to a charge of [C] 10.31 cents per barrel.~~

~~PUMPING CHARGE: Where pumping service is performed by Plains from its facilities at Midland to Basin Pipeline or Spraberry Pipeline, a charge of [C] 10.31 cents per barrel of 42 U.S. gallons will be made on all Crude Petroleum pumped into the other system, except that there will be no pumpover charge for crude petroleum received at Mungerville Field—University 7-14 Gathering, Scharbauer Mabee Station or Mabee South Station.~~

**Exceptions to Plains Pipeline, L.P.'s Rules and Regulations Tariff:**

~~Rule 7: The pipeline loss allowance of two-tenths of one percent specified in the rules and regulations will not apply to University Comanche Gathering, Martin County or movements from Curtis Station, Martin County to Midland Station, Midland County.~~

~~For Crude Petroleum received at Lowe Area Mabee Wolfberry Gathering, Andrews and Martin Counties, the deduction for incremental evaporation and shrinkage shall be determined in accordance with the following table:~~
