(1) Natural Gas Liquids delivered to Carrier that have an Ethane content of less than 20% will be assessed a Low Ethane Surcharge of [U] 1.55 Cents per Gallon. <sup>(2)(4)</sup>

(2) The rates herein are subject to increase each July 1, in accordance with the mechanism set forth in FERC regulation 18 C.F.R. § 342.3 or any successor thereto; provided, that if the indexing policy would decrease the then current rate, it shall not apply and said rate shall not be decreased.

(3) Incentive Rates are applicable to an Incentive Shipper, up to the volume of Natural Gas Liquids tendered by an Incentive Shipper that does not exceed the T&D Obligation established by its TSA.

(4) Rates published in this tariff shall terminate on November 30<sup>th</sup>, 2029.
