1. The Committed Shipper Rates listed in Table 1 are applicable to Shippers that have an effective TSA with Pipeline Operator that covers shipments originating from (i) the Asherton Production Batteries, ~~[W] and/or~~ (ii) the Asherton Station Truck Injection Point, and/or (iii) Solider Wash.
2. The rate set forth for this movement will be effective for all shipments made by the Committed Shipper on or after July 1, 2022, in accordance with the terms of the Committed Shipper's TSA with Carrier.
3. Any shipper that enters into a Transportation Services Agreement with Carrier and agrees therein either to (i) ship or otherwise pay Carrier for failing to ship a specified volume of crude oil or (ii) dedicates certain production for delivery to Carrier's system, in each case, for a period of at least one year, may qualify for a Committed Shipper Rate for the movement. 1. Shippers that do not otherwise qualify for the Committed Shipper Rates listed in Rate Table 1 above will be charged the rates listed in this Rate Table 2.
2. The Uncommitted Shipper Rate applicable to movements from Asherton Station Truck Injection Point, Dimmit County, Texas to NuStar 100 Series Tank Farm, Corpus Christi, Nueces County, TX or Midway Station, San Patricio County, Texas, Sunoco/Nustar South Texas System, San Patricio County, Three Rivers Refinery, Live Oak County, TX, or Harvest—Gray Oak Interconnect, Live Oak County, TX has been temporarily decreased by [U] 155.52 cents per barrel for shippers who ship greater than 2,500 barrels per day (as measured on an average daily basis during a month) of Uncommitted Volume from the rate stated in the above Rate Table 2 to encourage additional deliveries by shippers. This decreased rate is only available for a limited period and may be increased up to its previous level of [U] 261.53 cents per barrel or above by Pipeline Operator prior to the beginning of any shipment Month.
3. Any shipper that enters into a Transportation Services Agreement with Carrier and agrees therein either to (i) ship or otherwise pay Carrier for failing to ship a specified volume of crude oil or (ii) dedicates certain production for delivery to Carrier’s system, in each case, for a period of at least one year, may qualify for a Committed Shipper Rate for the movement. Interested shippers should contact Carrier for more information.

PUMPING FEE (except as otherwise noted, the pumping fee shall be applicable to all movements under this tariff Arrowhead Eagle Ford Tariff No. 5.20): All shipments received into Pipeline Operator’s system under this tariff will be subject to a charge of [U] nineteen and sixty-six hundredths cents
