Notes Applicable to Rate Table 2

1. Shippers that do not otherwise qualify for the Committed Shipper Rates listed in Rate Table 1 above will be charged the rates listed in this Rate Table 2.
2. The Uncommitted Shipper Rate applicable to movements from Asherton Station Truck Injection Point, Dimmit County, Texas to NuStar 100 Series Tank Farm, Corpus Christi, Nueces County, TX, Midway Station, San Patricio County, Texas, [N] Three Rivers Refinery, Live Oak County, TX, or Harvest – Gray Oak Interconnect, Live Oak County, TX has been temporarily decreased by [I] 150.57 cents per barrel for shippers who ship greater than 2,500 barrels per day (as measured on an average daily basis during a month) of Uncommitted Volume from the rate stated in the above Rate Table 2 to encourage additional deliveries by shippers. This decreased rate is only available for a limited period and may be increased up to its previous level of 253.21 cents per barrel or above by Pipeline Operator prior to the beginning of any shipment Month.

PUMPING FEE (except as otherwise noted, the pumping fee shall be applicable to all movements under this tariff Arrowhead Eagle Ford Tariff No. [W] 5.16 5.15): All shipments received into Pipeline Operator's system under this tariff will be subject to a charge of [I] nineteen and three hundredths cents (\$0.1903) per barrel pumping fee in addition to the transportation rates named here. The pumping fee set forth above shall not apply to movements from Freedom Interconnect, Dimmit County, Texas.
