### New Construction Commencement Report

### *16 TAC CHAPTER 8 RULE §8.115*

## New Construction Applicability (1 of 2)



- Newly constructed pipeline facilities, including extensions
- Replacement of existing pipe
- Relocated pipeline facilities
- Sour Gas regardless of length
- New Transmission 1 mile or greater

### New Construction Applicability (2 of 2)



- New, relocated, or replaced distribution is 3 miles or greater
- All distributions requiring a new system ID
- Required to be submitted 30 or 60 days from the start of construction
- For single systems, submit through PIPES
- Monthly reports (distribution/multiple segments) are submitted through <u>PS-</u> <u>48reports@rrc.texas.gov</u>

### What is RAMP?



- Security portal to access RRC online applications
- RAMP access is handled by the RRC Security Team
- RAMP accounts have a single set of sign-in credentials
